Te tūtohunga / Recommendation

a) Note the Economic Development Action Plan to address Auckland Council Group's role in Auckland's recovery 2021-24 (Attachment 1).

Te whakarāpopototanga matua / Executive summary

- 1. The Economic Development Action Plan 2021 2024 (plan) provides a coordinated reference point for the Auckland Council group's economic development activity over the next three years.
- 2. The focus of the plan is on services that can be explicitly used to stimulate economic development, economic recovery following the COVID-19 pandemic (COVID-19) and those that can be demonstrated to materially improve economic outcomes beyond the Auckland Council group.
- 3. The plan was adopted by the Parks, Arts, Community and Events Committee of Auckland Council in July 2021, following endorsement by Auckland Council and the Council Controlled Organisation (CCO) Chief Executive group on 24 June 2021.

Ngā tuhinga ō mua / Previous deliberations

4. There are no previous deliberations on this topic.

Te horopaki me te tīaroaro rautaki / Context and strategic alignment

- 5. Tāmakai Makaurau is the powerhouse of the New Zealand economy, accounting for close to 40% of national Gross Domestic Product. It will play a key role in the nation's economic recovery following COVID-19. Climate related economic impacts present an additional challenge.
- 6. The plan takes its direction from Auckland's key strategic document, the *Auckland Plan 2050* and other important strategies including *Te-Tāruke-ā-Tāwhiri: Auckland's Climate Plan* and *Kia ora Tāmaki Makaurau: Council's Māori Outcomes Framework.*
- 7. An extensive review of plans and strategies across the Council group (as related to economic development and recovery) was undertaken to identify common economic development themes, including statements of intent, operational plans and strategies, and local board plans.





- 8. The economic development outcomes from these key plans and strategies have been bought together to form a definition of economic development as one that is not just about economic growth but also supports the overall standard of living for individuals within our community. This definition is reflected in the overall purpose of the plan:
 - "The Auckland Council group's contribution to economic development enables a regenerative and inclusive economy for the people and wellbeing of Tāmaki Makaurau."
- 9. This purpose is supported by six objectives that broadly encapsulate the breadth of economic development activity that occurs across the Auckland Council group and act as an organising framework for the plan. These objectives are:
 - a) Destination Tāmaki Makaurau: attracting people and investment.
 - b) Local Tāmaki Makaurau: enabling thriving local economies.
 - c) Skilled Tāmaki Makaurau: supporting quality jobs and skill development.
 - d) Future Tāmaki Makaurau: preparing businesses for the future.
 - e) Enabled Tāmaki Makaurau: infrastructure that enables economic development.
 - f) Enabled Tāmaki Makaurau: regulations that enable economic development.
- 10. The objectives are supported by three guiding principles:
 - a) Transitioning to a low carbon and regenerative economy.
 - b) Supporting economic opportunities for Māori.
 - c) Responding to communities of greatest need.
- 11. Actions and sub-actions reflecting the Auckland Council group levers have been developed under each objective.
- 12. Measures against the objectives, progress on deliverables, performance measures and targets will be reported annually.

Key risk	Mitigation
Impacts of any future community transmission of COVID-19 on public transport (PT) patronage and revenue.	PT patronage growth is a significant focus for management, however the impact of any future community transmission of COVID-19 cannot be fully mitigated.
Funding challenges given financial pressure facing both Auckland Council and Waka Kotahi New Zealand Transport Agency (Waka Kotahi).	On-going discussions with both the Governing Body and Waka Kotahi.

15. Delivery of plan actions against AT will be delivered from existing budgets, subject to any future funding constraints as noted above.

16. Transitioning to a low carbon and regenerative economy is a guiding principle of the plan.

17. Supporting economic opportunities for Māori is a guiding principle of the plan and the Plan has been endorsed by Auckland Council's Arts, Community and Events Committee. Customer satisfaction is included as a performance measure for the plan.
